

## **The Power of Money**

### **The Campaign Contributions and Lobbying Expenditures of Power Companies and the Automobile Industry, 1999-2004**

## Introduction

This is a study of campaign contributions and lobbying expenditures by companies opposed to legislation to reduce air pollution in Maryland. Part One tracks \$4.2 million in lobbying expenditures and over \$440,000 in campaign contributions since 1999 from power companies (and their directors and key employees) opposed to legislation to reduce power plant emissions and to improve energy efficiency in the state. Part Two tracks \$1.6 million in lobbying and over \$330,000 in contributions over this same period from automobile dealers and manufacturers opposed to legislation to promote Low-Emission Vehicles (LEV's) in Maryland.

Coal-fired power plants and gas-burning cars are both a major source of air pollution, and Marylanders breathe some of the nation's dirtiest air. In 2002, the state ranked 4<sup>th</sup> in the number of days with dangerous levels of ground-level ozone; on several days the air in Baltimore and the Washington suburbs was toxic enough to trigger a Code Purple ozone alert day, on which children and senior citizens are warned to stay indoors. Ground-level ozone has been linked to an increased incidence of asthma in children and respiratory disease in people of all ages.

A June 2004 study by the nonprofit group Clear The Air found that emissions from coal-fired power plants damage not just Maryland residents' health—with Cumberland ranking as the second most dangerous place to live for power plant pollution in the country—but the state's economy. Over 100,000 lost work days were attributed to the inhalation of fine particle pollution from power plants, while the Maryland Department of the Environment has issued a fish consumption advisory for every river and lake in the state due to toxic levels of mercury.

While lobbyists for both power plants and the auto industry argue that higher environmental standards would hurt the state's economy by driving up the cost of doing business for affected companies, and while environmentalists argue that air pollution is causing both a public health *and* an economic crisis (in the form of decreased productivity from workers made sick by air pollution), this study is an attempt to show how money has shaped this debate.

Campaign contributions affect our political process in several important ways. A candidate who can raise more money than his or her opponents often stands a better chance of getting elected, while getting re-elected can depend on maintaining a good relationship with wealthy donors and potential donors who, displeased with a candidate's voting record, may be moved to give to their opponent. Given that many fundraisers are structured so that a donor giving the minimum will get in the door, a donor giving more will be seated at a "VIP" table with a candidate, and a donor giving still more will be given a one-on-one with the candidate, it is also clear that money buys access, and access means influence. Power companies and automobile manufacturers may always be able to

spend more on lobbying than environmental groups, but why should they be allowed to say which candidates have a better chance of getting elected?

### **Part One: The Campaign Contributions & Lobbying Expenditures of Power Companies in Maryland from 1999-2004**

Power plants are both a major source of air pollution and campaign contributions in Maryland. Appendix A of this study shows \$445,092 in contributions from four energy companies (and some of their key employees) which, in 2004, actively lobbied against HB 1172, a bill which would have forced power plants in Maryland to significantly reduce their emissions of sulfur dioxide, nitrogen oxides, and mercury. These figures include contributions from these companies, their subsidiaries, PAC's, and from senior employees.

Three of these companies—Allegheny, Constellation, and Pepco—also lobbied against a bill (SB 654) which would have indirectly reduced air pollution by establishing a fund to help make residences and businesses more energy-efficient—a fund which was abolished after these same companies successfully lobbied to deregulate electricity in Maryland in 1999. (SB 654 was also opposed by Columbia Gas, The Greater Baltimore Board of

Realtors, and Washington Gas—entities whose contributions are not included in this study.)

The following table shows lobbying expenditures by these companies since 1999. Figures for 2004 are for the period 11/1/03-4/30/04.

#### Analysis: The Who & Why of Contributions from Power Companies

To what extent are contributions an expression of a donor's political philosophy, and to what extent are they an attempt to gain access to a candidate? During the 2002 gubernatorial election, Constellation Energy gave \$5,000 to then-candidate Robert Ehrlich (R) and \$5,000 to his opponent Lt. Gov. Kathleen Kennedy Townsend (D). Constellation CEO Mayo Shattuck gave \$2,000 to each candidate, and has since given another \$4,000 to Ehrlich. Constellation Director Edward Crooke gave \$1,000 to both, while Director Frank Heintz gave \$1,250 to Ehrlich and \$3,000 to Townsend. Giving to both candidates in a race renders the act of giving meaningless as a form of ideological expression; rather it is an attempt to guarantee access to whomever wins the race.

Contributions by Pepco Executives provide another interesting example of a group of wealthy donors supporting candidates across the ideological spectrum. On December 18, 2003, Gov. Ehrlich received \$21,050 from seven senior Pepco employees—four of whom joined three other Pepco employees in giving a total of \$14,500 to the New Jersey Democratic State Committee on February 11, 2004.

Incumbents received the lion's share of contributions from these power companies. Challengers running against incumbents received just \$2,490 during the five years covered by the study, while incumbent officials received \$266,242, or **one hundred times as much**. (The remaining contributions went to candidates in races in which there was no incumbent.)

#### **Part Two: The Campaign Contributions & Lobbying Expenditures of the Automobile Industry**

Automobiles are Maryland's biggest source of smog and airborne soot, and the EPA estimates that the average Marylander breathes air 10 times more polluted than allowed by safety guidelines for airborne toxins. Since 1999, automobile dealers and manufacturers opposed to legislation to promote Low-Emission Vehicles (LEV's) have

given \$337,142 to candidates in Maryland. In 2004, these donors opposed HB 314, a bill which would raise emission standards for automakers, require two percent of the new cars sold in Maryland to be hybrids or alternative fuel vehicles, and six percent to be cars with conventional technology but better seals to reduce emissions. Seven other states have passed similar legislation, among them California, New York, and New Jersey.

The Maryland New Car & Truck Dealers PAC was the single biggest donor with \$98,403 given from 1999-2004. An additional \$234,739 was contributed by individual car and truck dealers, while the Washington Area New Auto Dealers PAC gave \$3,250, and General Motors gave \$750.

Not included with these contributions (or the below lobbying expenditures) are monies spent by the American Petroleum Institute, which reported lobbying on this LEV bill in 2003, but not in 2004.
