Dear Jeremy:

As alumni of Skadden,¹ we write to express our profound disappointment and deep outrage regarding the firm's recent agreement with President Donald Trump. At a time when rule of law, freedom of speech, and the adversarial system collectively face existential threat, Skadden's agreement with President Trump emboldened him to further undermine our democracy. The deals Willkie Farr and Milbank struck with President Trump this week evinces the deeply disturbing behavior that Skadden helped normalize.

We were shocked to hear about Skadden's concessions, concessions given under the threat of an executive order whose substance had already been blocked by a federal court. The firm indoctrinates every Skadden employee who walks through the firm's halls into the legacy of Joe Flom, the firm's most esteemed founding partner. We were told that while other firms scorned hostile takeovers, Joe embraced them and relished his reputation as a maverick, a street fighter. We were told that his name evoked such terror on Wall Street that the firm was frequently paid retainer fees to prevent him from representing potential opponents. For a firm to take such pride in this rebellious tradition, it's embarrassing what Skadden did.

Not only was Joe a formidable adversary in mergers and acquisitions, he was a formidable defender of civil rights and underrepresented communities as well. Having faced discrimination himself, he championed diversity at the firm, being instrumental in hiring the firm's first female associate, and left an indelible mark on the public interest legal profession. In 1988, he founded the Skadden Fellowship Foundation, which since its establishment has provided opportunities for over 1,000 lawyers to advocate for marginalized communities on issues such as immigration and racial justice. During some of our tenure, the firm carried on Joe's philanthropic spirit and established the Immigration Impact Project, which many of us participated in, as an ostensible direct form of resistance against President Trump's "Muslim Ban" in his first term. In light of this history, we find Skadden's capitulation to Trump to be hypocritical, cowardly, and downright shameful.

As attorneys, we all took an oath to uphold the Constitution of the United States. As one of the country's most powerful and most profitable law firms, Skadden's influence over the legal profession cannot be understated. In light of Skadden's position, it is outrageous and self-interested that rather than fulfilling the legal profession's oath and standing in solidarity with fellow law firms that were fighting to uphold the Constitution, Skadden caved to bullying tactics instead. Not only did Skadden's decision leave a painful stain on Joe's legacy and Skadden's reputation, but your decision also sent the country down an extremely dangerous path. During our tenure, we told clients we'd walk through walls for them. It is incredibly disappointing the firm won't do the same for the Constitution.

As alumni who have proudly represented Skadden in a variety of practice areas, we call on you to clearly affirm the firm's commitment to reject the administration's attacks on the judiciary, the Constitution, and rule of law before it's too late.
